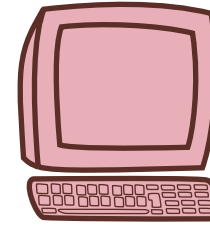
Therapy

- Comprehensive service delivery



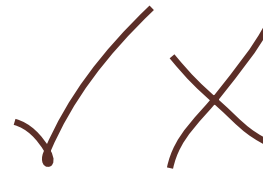
Court Prep

- Looking after the interests of the child



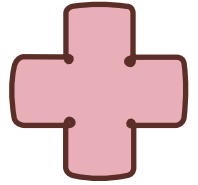
Research
